

Degenerate Art: The Attack on Modern Art in Nazi Germany, 1937





Our upcoming Chapter event will be an "only in WPO" type experience. The fabulous Neue Galerie, focused on German and Austrian 19th and 20th century art, provides us with the perfect backdrop to explore the world of Nazi Stolen Art. We will begin with cocktails and hors d'oeuvres in their famed Cafe Sabarsky. Guests are welcome to visit the third floor on their own prior to the start of the panel discussion in the Klimt Gallery. Hailed by the New York Times as "quietly devastating" this show highlights how the Nazis first came for the art that ran counter to their Aryan ideas of race and culture before turning to things more deadly.

Our panel presentation will take place in the main gallery where the world famous Gustav Klimt "Portrait of Adele Bloch-Bauer"

is exhibited. Described by art critics as a modern "Mona Lisa," this painting's history will act as a key to unlock a greater understanding of the enormity of the Nazi theft. Each member that signs up will receive a DVD copy of the famous documentary film *The Rape of Europa*. We urge you to watch the film prior to the event in order to enhance the evening's take home value.
