Honorable David M. Walker is President and CEO of the Peter G. Peterson Foundation. As Comptroller General of the United States and head of the Government Accountability Office (GAO) from 1998 to 2008—spanning both Democratic and Republican administrations—he served as the federal government's chief auditor. Appointed by President Bill Clinton and confirmed unanimously by the U.S. Senate, he was an outspoken, nonpartisan advocate for addressing the major fiscal and other sustainability challenges facing the country. He also enacted transformational reforms at the agency and within the accountability profession. Prior to his appointment to run the GAO, he served as a Partner and Global Managing Director of Arthur Andersen LLP and in several government leadership positions, including as a Public Trustee for Social Security and Medicare, from 1990 to 1995, and as Assistant Secretary of Labor for Pension and Welfare Benefit Programs during the Reagan administration. Although no longer the U.S. government's chief auditor, he continues to serve as a global accountability expert as Chairman of the United Nations Independent Audit Advisory Committee. He also serves on the boards of the Committee for a Responsible Federal Budget and the Partnership for Public Service. He has authored two books, is a regular commentator, and is the subject of the critically acclaimed documentary I.O.U.S.A.

Yan Zhang, CPA, is a Director in Eisner LLP's technical services group, with more than 12 years of accounting and auditing experience. She has specialized in periodic and transactional filings with the SEC as well as private placements, carve-outs, mergers and acquisitions, and divestitures.
