Larry and Howard are Co-Chairs of Herrick's Art Law Group. They are noted for their representation of foreign governments, victims of the Holocaust, and families of renowned artists in connection with the recovery of art and antiquities. They have been leaders in the field since successfully representing the Weimer Art Museum in the landmark case of *Federal Republic of Germany v. Elicofon*, in which two early masterpieces by Albrecht Durer, stolen at the end of the Second World War, were recovered and returned to the Museum. Larry and Howard successfully represented the heir of the famous Jewish art dealer, Jacques Goudstikker, in her efforts to recover 200 Nazi-looted artworks from the Dutch Government, as well as the heirs of the Russian artist, Kazimir Malevich, in connection with their claims against New York's Museum of Modern Art, Harvard University's Busch-Reisinger Museum, and the City of Amsterdam's Stedelijk Museum. They currently represent the Estate of Lea Bondi Jaray in a pending litigation to recover a Schiele painting "Portrait of Wally," confiscated by a Nazi agent in Austria in the late 1930's, and are acting for many museums, collectors and foreign governments in connection with a variety of cultural property matters.

Steven D. Feldman, A92

Steve is a lead partner in the White Collar Defense practice at Herrick, Feinstein LLP. Following six years as a federal prosecutor, Steve now represents and defends individuals and companies involved in white collar criminal matters including securities fraud, insider trading, and public corruption cases before federal and state law enforcement and regulatory bodies. Steve is also a member of UJA's Criminal Law Committee Executive Council, and a trustee of the Beit Rabban Day School. During his years at Tufts, Steve was a member of Hillel's Student Board responsible for Jewish program planning on campus, President of the Tufts Israel Network, a member of Zeta Beta Tau Fraternity, and a student at Hebrew University for a semester. Following graduation, he was the Senior Legislative Assistant at the American Israel Public Affairs Committee (AIPAC) before attending Georgetown University Law Center.

Rabbi Jeffrey A. Summit, AG88, AG95, AO3P, AO5P

Rabbi Summit is the Neubauer Executive Director of Tufts Hillel. He also serves as Associate Professor in the Department of Music and as the University's Jewish Chaplain. He holds rabbinic ordination from the Hebrew Union College-Jewish Institute of Religion and a Ph.D. in Ethnomusicology from Tufts University. Rabbi Summit is the author of *The Lord's Song in a Strange Land: Music and Identity in Contemporary Jewish Worship* and with photojournalist Richard Sobol, is co-author of *Abayudaya: The Jews of Uganda*. He recorded the CD, "Abayudaya: Music from the Jewish People of Uganda" for Smithsonian Folkways Recordings, which was nominated for a Grammy Award in the category of Traditional World Music. Rabbi Summit's current project is "Mirembe Means Peace: Documenting an Extraordinary Story of Religious Harmony and Coffee in Uganda."
